# **United States Volt Hockey Association Participant Liability Waiver and Release Form**

**Introduction:** Participation in Volt Hockey through the United States Volt Hockey Association (USVHA) is a rewarding experience that promotes inclusivity, empowerment, and community. To ensure a clear understanding of responsibilities and risks, this Liability Waiver and Release Form is required for all players and coaches.

## 1. Acknowledgment of Participation: By signing this form, I acknowledge and agree to the following:

- Participation in Volt Hockey activities, including practices, games, and events, is voluntary.
- I understand the nature of the sport and acknowledge that it involves inherent risks and harm of physical activity and the use of adaptive equipment.

## 2. Assumption of Risk:

- I acknowledge and voluntarily assume all risks associated with participation in Volt Hockey, including but not limited to:

  - Equipment-related incidents or malfunctions.

Waiver and Release of Liability:** In consideration of being allowed to participate in Volt Hockey activities, I hereby release, waive, and discharge the USVHA, its officers, directors, employees, volunteers, agents, and affiliates from any and all liability, claims, demands, or causes of action, including but not limited to:

  - Claims arising out of any first aid or medical treatment provided in connection with participation.

- I understand that I am responsible for any medical expenses incurred as a result of such treatment.

#### 5. Equipment Responsibility:

- I agree to use USVHA-provided equipment responsibly and follow all guidelines for proper operation.
- I acknowledge that any intentional damage to equipment may result in financial liability for repairs or replacement.

#### 6. Media Consent:

 I grant the USVHA permission to use photographs, videos, or recordings of me taken during activities for promotional, educational, or informational purposes without expectation of compensation without prior approval other than this consent.

### 7. Code of Conduct Agreement:

- I agree to adhere to the USVHA Code of Conduct and policies specific to players and coaches.
- I understand that violations of the Code of Conduct may result in disciplinary action, up to and including dismissal from the program.

## 8. Confidentiality Agreement:

• I affirm that I am of legal age (18 years or older) to sign this form, or I have obtained the consent of my parent/guardian (if under 18) as indicated below.
